MINUTES - ANNUAL MEETING OF THE CONGREGATION - JUNE 12, 2016

Call to Order: Vice President Jerry Katzmann officially counts a quorum of more than 50 members.

Minutes of Annual Meeting held June 7, 2015: Motion by George Thompson, second by Marge Dalen to approve the minutes as presented. No discussion. Motion carries.

Reports on the 2015-2016 Church Year:

I. Officers

- A. President There is no president's report as David Kallmes is unavailable.
- B. Vice-President See Annual Report. In addition to the Annual Report, VP Jerry Katzmann would like to add:

At a May Board Retreat, the board identified 5 goals:

- 1. Test an administrative coordinating-team structure in an effort to move toward Policy Governance
- 2. Edit Bylaws in a few select areas
- 3. Develop and enter into a board covenant
- 4. Improve communication between Board members and congregants
- 5. Support the Ministerial Search Team.
- C. Treasurer See pages 10-15 of Annual Report
 - 1. We have a balanced budget
 - 2. Budgeting was guided by the needs and wants of Committees
 - 3. Staff is being paid fair wages and we are a Fair-Share congregation again
 - 4. We exceeded the 150th *JumpStarter* fundraising expectations, we should start seeing improvements over the summer.

II. Committees and Councils

- A. Annual Reports from Staff and Committees & Councils
 - Jerry would like to note: The recognition of volunteers during the flower service
 was inspiring as are the committee and staff reports in the Annual Report.
 Please take time to look through this as it is a wonderful representation of what
 our congregation does throughout the year.
 - 2. Jerry highlighted the Stewardship Report: A special effort was made to contact non-pledging members. At the beginning of the year there were 53 members who were not pledging. After the efforts of the stewardship team, there are only 14 members who are unable to pledge.
 - 3. Questions from the annual meeting attendees:
 - a) What do we pay in UUA/Mid America dues? Response: \$85/member
 - b) What happened when we did not pay fair share? Response: We pledged the amount we could
 - c) Additional discussion about membership/pledging/fair share.

- C. Caring Vikki Wolff is stepping in as Chair.

- D. History Leslie Redinger is stepping down as Chair. A new chair has not yet been named.
- E. Hospitality & Growth Rebekah Rolstad is stepping in as Co-Chair.
- F. Design Richard Hutton is the new Chair.
- G. RE for Children and Youth Committee is now a Council.
- H. Worship Anne Black-Sinak is the new Chair.
- I. Social Justice Julie Gilkinson encourages all to read the SJ report and hopes it inspires people to join.
 - Paula Horner reported we are in the 2nd year of a 3-year pilot to become a UUA Accessible Congregation. Last year, Paula attended General Assembly and participated on a panel talking about Accessibility and Inclusion. Over 150 people participated in that session.
 - 2. Poverty Task Force has changed its name to Community Outreach.

 - i) Printed report is a report of Activities
 - (1) Amend Joe Mish's name in Minister's Report (it is misprinted)
 - ii) Rev. Fritz's Goal as stated at the first meeting with members in August was to "Have Fun". When asked for a show of hands as to belief if this goal was achieved, it was overwhelmingly positive.
 - iii) To speak to the health of the congregation, Rev. Fritz would like to note that attendance at both services is roughly equal, showing a healthy congregation.
 - iv) Rev. Fritz is looking forward to the 2nd year of his interim ministry here.

- v) He reiterates that part of the job of an Interim Minister is to look at our history as well as toward the future.
- vi) Rev. Fritz highlighted there is a pilot process going on the Southern US at UU congregations, trying to move from 'head-count' fair share giving to a percentage of budget for giving.
- vii) We are also now a fair-compensation congregation for our staff. This was after looking at the position descriptions and moving one 'up' a level.
- viii) Another thing ministers look at is the division of leadership among staff and members. The Board is willing to address delegation of authority and test out a shift toward Policy Governance.
- ix) This is a good congregation, a strong congregation, and should do well in the search for a new, settled minister.
- x) Keep moving forward and develop our vision for the future.
- xi) Rev. Fritz would like to thank the congregation for "all of the fun" and looks forward to the next year.
- xii) Members of the Ministerial Search Committee: Mary Amundsen, Aleta Borrud, Judy Jensen, Amy Nelson, Dave Siljenberg, Robin Taylor, and George Thompson. Meetings begin this week.

MINUTES - SPECIAL MEETING OF THE CONGREGATION - OCTOBER 30, 2016 12:15 p.m. -- Sanctuary Meeting Minutes

- 1. Call to Order: President Jerry Katzmann requested a call of members to determine a quorum. A quorum of more than 50 members was determined. The Special Meeting of the Congregation was called to order by President Katzmann. Ann Hutton, Secretary and Chair of the Ad Hoc Bylaws Committee reviewed the proposed amendments.
- **3.** Article 3, Section 3.1 --- Motion by Amy Nelson, second by Marge Dalen to approved the proposed amendment. Discussion included motion to amend by Phil Wheeler, second by Paul Scanlon to add the phrase "financial or other" prior to the words contribution of records. Motion to amend carried. The amended motion carried.
 - **New language as approved:** After the initial period of membership, membership is maintained by making and paying a pledge, making a financial or other contribution of record, or by affirming continued interest in membership, in writing on a form provided by the church. Only members may be members of the Board of Directors (hereafter referred to as the Board), be Officers of the Church, or vote at any meeting of members or on any action taken by the members without a meeting. Only members are entitled to notice of meetings of members.
- 4. Article 4, Section 8 --- Motion by Kim Edson, second by Ramona Barr to accept the proposed amendment. Discussion included a motion to amend by Phil Wheeler second by Kathy Brutinel "except where specified in the bylaws." Motion to amend carries. Additional discussion requested an addition of the phrase and/or. Grammatical additional "and/or" accepted as a friendly amendment. The amended motion carried.
 - **New language as approved:** Only members may vote. Each member shall have one vote. There shall be no cumulative voting. Members may vote by voice, show of hands, paper and/or electronic ballot at the discretion of the Board except where specified in the bylaws.
- **5. Article 7, Section 3** --- Motion by **Ramona** Barr, second by Patty Trnka to accept proposed amendment. Discussion. Motion carried.
 - **New language as approved:** The Board of Directors is the governing body of the Church. It has responsibility for the property of the Church, the conduct of its business affairs, and the administration of its services. By its own action or through delegation to the Minister, councils, committees, or tasks groups, the Board shall:
- **6. Article 8, Section 3** --- Motion by **Kathy** Brutinel, second by Amy Nelson to accept the proposed amendment to eliminate specific reference to the Committee on Ministry. Discussion. Motion carries.
- 7. Article 8, Section 6 --- Motion by Amy Nelson, second by Patricia Wimmer to accept the proposed amendment. Discussion included a motion to amend by Randy Crawford, second by Charyssa Cobb to delete the reference to the Minister. Motion to amend carried. Motion by Phil Wheeler, second by Amy Nelson to add the word "employment." Motion to amend carried. The amended motion carried.
 - **New language as approved:** The Personnel Committee shall work with the Minister to create an effective, efficient, and responsive working environment, and to recommend fair compensation

and benefit packages in line with UUA guidelines. The Committee will maintain a process for hearing grievances related to personnel matters and advise the Board and Minister on matters pertaining to state and federal employment law. The Committee will be composed of at least three church members appointed by the Board.

8. Article 9, Section 2 --- Motion by Kathy **Brutinel**, second by Bill Thompson to accept the proposed amendment. Discussion. Amendment motion carries.

New language as approved: At an Annual Meeting or other meeting duly called for the purpose, the Church shall elect a Ministerial Search Committee for the purpose of recommending a ministerial candidate to the membership. The decision to call a Minister will require a 75% vote of the members of the Church present at a meeting duly called for that purpose.

9. Article 9, Section 4 --- Motion by Ann Hutton, seconded by Kim Edson to delete the wording of the amendment as initially proposed and to approved the recommended new wording. Discussion included a motion to amend by Phil Wheeler, second by Ramona Barr to allow electronic voting at the dismissal of a minister. Motion to amend failed. The amended motion carried.

New language as approved: A motion to dismiss the Minister may be considered only at a Special Meeting duly called for that purpose. Such a Special meeting may be called only by a majority vote of the total Board membership or by a written petition signed by 20% of the current church members.

Notice of such a meeting shall be given no fewer than 30 days in advance of the meeting. Votes on the motion shall be cast by written ballot.

If the total number of ballots cast comprises at least 51% of the members of the church, the Minister may be dismissed by a simple majority vote of the members present and voting at the Special Meeting.

10. Meeting adjournment: President Jerry Katzmann commended those present for acting on our fifth principle: The right of conscience and the use of the democratic process within our congregations and in society at large. Having no further business to come before the congregation, President Katzmann adjourned the special called meeting.

Luke Stevens-Royer as our next settled minister. Jerry requested a call of members to determine a quorum. A quorum of more than 50 members was determined with a total attendance of 158 individuals and 151 voting members present.
- 4. **Congregational Vote:** Motion by Amy Nelson on behalf of the Ministerial Search Committee to extend a call to Rev. Luke Stevens-Royer as our next settled minister; second by acclaim. Jerry called for a voice vote:

In favor: 151 Opposed: 0 Abstaining: 0

5. Amy offered details pertaining to the next steps and a future announcement following a decision by Rev. Luke.

The Ministerial Search Committee will collect cards from anyone wanting to offer good wishes and support to our new settled minister. There will be a collection box in the lobby until May 18. Everything will then be sent to Rev. Luke.

The Board has functioned well during the 2016/17 church year. The Board had a leadership retreat in August, led a Special Congregational Bylaws meeting, and had monthly Board meetings (below).

The Board has explored a new leadership model in order to move to Policy Governance. We established a Program and Administrative Coordinating Team (PAC-Team) and delegated some responsibilities to it. In addition, the Board has set limitations on PAC-Team authority. The PAC-Team submits a monthly report to the Board on the progress toward the fulfillment of our vision as well any activities that have gone beyond their limitations. This year's PAC-Team membership was the Minister, Board Vice President, and Board Treasurer. They led the Program Council at its quarterly meetings. Bylaw amendments formalizing the PAC-Team and Program Council descriptions will come forward next church year after we have another year of experience and have worked with the new minister.

The establishment of the PAC-Team has freed the Board to focus on visions/goals, communication, and stewardship:

<u>Vision/goals</u>- a congregational visioning workshop led by Rev. Fritz identified a primary vision of ministering to children, youth and young families and subsequent visions of outreach to community partners, intergenerational fellowship, and adult education. The Board and PAC-Team focused this year on the primary vision.

Purpose:

To promote stewardship and oversee the annual stewardship canvass.

Activities of the Committee:

- Due to the imminent calling of a new settled minister "A Fresh Start" theme for the canvass was chosen. With the subtheme of "You belong to this church, and this church belongs to you".
- Seven "Cottage Meetings" held by the board in February to discuss what our church and its representatives have done right, as well as what things will need to be accomplished in the coming year(s).
- Sent congregational mailing March 02 with the results of the cottage meetings.
- "Matters of the congregation" announcements made at services March 5th and 12th by Jim Jensen at 9AM
 by Chris Wendt at 11AM.
- The staffing of a pledge table in the foyer to personally hand out forms March 5th, 12th, and 19th.
- Stuffing and mailing pledge forms to those that hadn't yet picked them up in person by Sunday March
 19th
- May 2017 Calling and/or e-mailing those people that have pledged in prior years, but haven't yet returned a pledge form for this year.
- A stewardship goal of \$470,000 was reached by minister, staff, committees and Program Council. This
 goal included increased hours for the Coordinator of Congregational Life, addition of a part-time office
 assistant, youth coordinator, and social justice coordinator. These positions would only be filled if the
 pledge income increased enough to do so. As of this report 188 pledge forms have been returned totaling
 \$381.709 and \$46,448 in sustaining pledges (form on file no new form received) for a total of \$428,157.

PERSONNEL COMMITTEE 2016-17 Submitted by Randy Crawford, Chair

Committee Composition

During the church year, the Bylaw concerning the composition of the Personnel Committee was amended. The Bylaw now states the committee will be composed of at least 3 church members appointed by the Board. Currently, the Committee consists of one Board member, one member selected by the staff, and one member who was recruited by the other two.

Staff Changes

Ryan Shriver resigned as Director of Religious Education as of May 31, 2016. Ramona Barr & Kate Thompson-Jewell served as Co-Summer Directors of Religious Education from June 1, 2016 to September 15, 2016. On September 16, 2016, Joyce Rood took over as Acting Director of Religious Education.

Activities of the Committee

The newly-formed Committee first met with Rev. Hudson to review current issues raised by the staff. Several topics were discussed that he felt were in need of addressing and, as the year progressed, these were addressed.

Next, the Committee met with the staff. This meeting was also used to find out what issues the staff felt needed to be addressed.

The first change to the Personnel Policy implemented this year had to do with Paid Time Off (PTO). Before this change, PTO had only been offered to employees who were scheduled at least .5 Full Time Equivalent (FTE). This policy was changed to include all employees regardless of their FTE, and all employees will begin earning PTO based on actual hours worked regardless of their FTE. The schedule of the rate at which individual employees earn PTO is based on formulas depending on years of service.

Next, the Personnel Policy was amended to clarify who is eligible for the various kinds of insurance benefits offered to employees. Before this change, the Personnel Policy only designated Health Insurance as being available to employees working 1,000 or more per year and did not clearly state who was eligible for Dental, Long Term Disability, and Life Insurance. Policy now states anyone working over 1,000 hours per year is eligible for Health Insurance, Dental Insurance, Long Term Disability Insurance, and Life Insurance.

In the fall of 2016, the Department of Labor issued a new ruling concerning exempt status for salaried employees and the salary level required to classify those employees as exempt from overtime. This new rule was to go into effect on December 1, 2016. It was decided, by definition, the only person on staff exempt from overtime was the Minister and, as such, all hours worked for all other staff should be tracked and overtime paid for any hours worked over 40 in any given week. Subsequent to all of this, the new proposed legislation pertaining to this topic was struck down and this law never went into effect. Currently, we classify all employees other than the Minister as hourly.

During the year, Rev. Hudson also brought up the topic of how to properly address longevity in our pay structure. At present, the church has always strived to maintain our employees at least at the 50% of the UUA Fair Compensation guidelines (obviously depending on budget constraints); however, there was no provision to address longevity of employees. Clearly, most of our staff has been with us for a considerable length of time. Rev. Hudson proposed a new scale of automatic salary increases over and above the 50% UUA Fair Share guidelines to be implemented based on years of service. The increases necessary to bring our current staff to those levels based on this new scale will amount to approx. \$5,000 in the 2017-18 budget and will be considered priority number 1 as far as staff compensation goes.

With the news of a week ago of our new Settled Minister, Rev. Luke Stevens-Royer, the Committee looks forward to working with Rev. Luke moving forward. The Committee would also like to thank Rev. Hudson for the time and effort he put forth over the last year bringing our Bylaws and Personnel Policies pertaining to staff into closer alignment with Common Practices in the UUA.

The Director of Religious Education for Children and Youth provides creative leadership and support for the church's children and youth, in collaboration with Religious Education Council for Children and Youth.

Programming

Meeting Information

The Hospitality and Growth Council members met every other month with six regular meetings during the year. They exchanged information and their needs for membership events with the Council including participation in Pathway classes, the New Member Sundays, a potluck for new members, and providing supplies for membership events. At least one co-chair attended the Program Council meetings held throughout the church year.

Regular Activities of the Council

The Council continues to focus on the overall picture of Fellowship, Hospitality, and Membership, and it helps coordinate activities among the committees. We have had dedicated, hard-working committee members who focus on creating a welcoming church for visitors and members. We have continued to use a team approach to staffing the Sunday morning volunteers, and we are focusing on creating multi-generational fellowship activities.

John MacLaughlin calls visitors within a few weeks after they have completed the visitor form at the guest table and has shared any information he receives with the Coordinator of Congregational Life.

Although individuals on the Council have been volunteering to do the work, there is not an official chair right now. Melissa hopes to get the committee re-formed and to recruit new members.

PUBLICITY

Pictures of new members are now posted on the website; biographical information will be added soon. The June Venture will feature information on new members. Pictures and biographies will not be published in the eNews.

Although it was our hope to create a few ads in public advertising venues, most have become too expensive for the \$500 available in the Communication's budget. We have placed an ad on Facebook of our Love Your Neighbor sign; churches cannot place ads on Mom blogs.

Annual Report 2016-17

We investigated having a small street sign attached to the one on 6th Street and 17th Ave SW that holds those to the Congregational and Kingdom Hall Jehovah's Witness churches. Our request was turned down because the city traffic department does not allow this type of sign to be put up.

HOSPITALITY

We continue using the five Sunday Hospitality teams. All teams would welcome and benefit from adding more volunteers. To encourage more visitors and members to help, we are planning to have a Hospitality volunteering event with a bulletin insert in the early fall, schedule our attendance at Pathway classes where we can talk about volunteering on our teams and in other church activities and demonstrate using Sign-Up Genius, post team signup sheets at the coffee hour, connect with Joyce Rood to seek youth interested in being greeters and coffee hosts, and create a bulletin insert to seek ideas/hosts for Fellowship events.

Cynthia Daube has organized a group who provide treats for the coffee hour for each Sunday during the year. Our volunteer bakers include Marty Aleman, Joyce Wood, Shayna Johnson, Lynne Kirklin, Phyllis Berry, Darrel Waters, Dianne Clossen, Betty Devine, and Cynthia Daube.

Members of the Council coordinated, purchased food and supplies, set up, and prepared food for the annual meeting and for the dessert potluck for the ministerial candidate.

Starting last fall, Ron Chrisope created name tags for new people with a colored border so that the congregants can know that this person is new to the church. Blue was used in 2016 with green to be used throughout 2017. This enables us to have an indicator of how long the person has been attending. As they join the church, their tag is changed to show the year of joining in the upper right corner.

The Hospitality and Growth Council guidelines approved by the Board in the summer of 2015 were submitted with a few deletions and corrections to represent current practices.

Major Expenses for the 2016-2017 Year

Miscellaneous supplies and snacks were provided for Fellowship events such as potlucks, Thanksgiving dinner, Christmas Eve receptions, potluck for ministerial candidate, annual meeting and other gatherings as needed. Donations of supplies, food and money have continued to cut the overall expenses for Fellowship events. The Clara Barton Guild has continued to fund the purchase of coffee, tea, hot chocolate, lemonade/juice, sugar, powdered creamer, storage bags, food gloves, dish soap and dishwasher detergent.

Membership costs have included the purchase of UUA pamphlets and wallet cards for Pathway, food for New Member Sundays, and gifts for new members including church directories, church cookbooks, shopping bags with the church logo, votive lights, cards, and books for adults and children.

Council Goals for the 2017-2018 Year

The Council continues to follow our mission to facilitate the development of a congregation that welcomes guests, strives to be warm and caring, and encourages membership and participation in our church community.

We will continue to work with the Communications Committee on our strategies for creating awareness of the church in our community through our publicity choices.

We will continue to use the church's website, the Weekly eNews and Facebook to get information to guests and members concerning fellowship, membership, and hospitality needs and activities.

We will continue to develop strategies to encourage new members to join one of the teams and to encourage youth and family participation on hospitality teams.

We want to develop a consistent process for contacting members who leave the church.

 - C. with younger families who seek support in raising children
 - D. with young children who seek naturally and revel in older companionship
- 2. Offer O.W.L at other age levels
- 3. Offer the UU Religious Award classes for UU Boy and Girl Scouts
- 4. Continue to try to grow and strengthen the W.H.Y. Youth Group
- 5. Find a sustainable way to replenish the Youth Scholarship Fund
- 6. Create an RE Council information packet for members joining the council
- Provide Leadership Enrichment opportunities for Council Members such as Midwest Leadership School, UUA trainings and enrichments, or any pertinent classes offered by our own Leadership Development or Nominating Committee
- 8. Develop a procedure for documenting misbehavior of students.
- 9. Develop a new Teacher Orientation/Training Session for the Fall RE Program
- 10. Develop a Parent Orientation/Expectations Session for the Fall RE Program.

Of Note

Tara Freimund, our original Council Chair, stepped down mid-year following a bicycle accident which left her with a concussion that caused her to have to vacate the position. Ramona Barr stepped in to finish out the year. We were again struggling to fill several positions on the Council, most poignantly that of secretary, which leaves the chair having to take notes and run meetings which is not only inefficient, but ineffectual. We also felt the lack in not having a presence on the Worship Committee. We are very encouraged by the focus on RE and families this past year and appreciate Rev. Fritz's help in getting RE family feedback through ZOOM Meetings. Although we approved the Y.A.C., we have such a small youth group currently that it's full implementation is not yet in place as it was approved, but rather in a much scaled-back version.

Project Legacy June 19, 2016 \$707.51

An organization providing hope, connections and support to youth of color ages 17-24 who are refugees, homeless, formerly gang-involved or recently incarcerated allowing them to transform their lives and become contributing members of our community.

P-Fund MN Scholarship July 17, 2016 \$493.00

The foundation annually awards thousands of dollars in grants and scholarships to GBTQ- related organizations and individuals throughout the upper Midwest.

Kathe Yoss Youth Scholarship August 21, 2016 \$753.00

PossAbilities is a private, non-profit organization that creates opportunities for children and adults with disabilities to contribute and connect with the community. This scholarship is used to help with camp fees or activity fee so kids can participate in the activities of their choice.

Hawthorne Helps September 18, 2016 \$1,058.42

This is the second year of a partnership with School District 535's Hawthorne Education Center. The Education Center offers a large range of programs that offer over 500 adults and youth 16 and older a personalized approach to instruction and a better future. A mini store staffed by UU volunteers is set up at the school with much needed items that can't be purchased with Snap (food stamps). The store is open every two weeks and students are able to select two items such as toothpaste, toilet paper, shampoo etc.

Empowerment Center October 16, 2016 \$1,283.57

A collaborative project where multiple agencies with shared goals and values will co-locate at the old Gage East elementary school site to provide programming for low income and homeless families and youth living in the new Gage East apartments. The Empowerment Center will not duplicate services but instead make them more accessible. The old school building needs to be renovated: a new roof, windows, HVAC system etc. This was a one-time capital campaign.

Family Promise Rochester (IHN) November 20, 2016 \$1,057.00

Interfaith Hospitality is a program of Family Promise of Greater Rochester. This organization has a very small paid staff and a larger network of volunteers from 40 faith communities. Food and shelter are given to families with children who find themselves without a place to live. They are housed in various host churches for a week at a time, giving them a chance to regroup, rejuvenate and get back on their feet with dignity. A family stabilization counselor works with the families daily to achieve and maintain independence.

Standing Rock Sioux Tribe December 4, 2016 \$1,928.05

(Via the Bismarck Mandan UU church)

The Standing Rock Sioux Tribe mounted a peaceful resistance to the Dakota Access Pipeline (DAPL) route because it would desecrate a cultural site and jeopardize their water supply. It was met with violence. The Water Protectors called for support to sustain their efforts, especially legal defense. The Bismarck /Mandan church was very involved

in providing support and agreed to serve as a non-profit conduit for financial donations directed to Oceti Sakowin Camp.

Community Food Response (CFR)

December 11, 2017

\$747.00

CFR was formed back in 1993 to help address the issue of hunger in our community. For 24 years, various local businesses have donated unused prepared food that would otherwise be discarded. Volunteer drivers pick up this food 3 days a week. Then at Bethel Lutheran church, additional volunteers get the food sorted and given out to people in need.

UUSC/ Guest at your table

December 18, 2016

\$2,151.50

Guest at Your Table is an annual fundraising and education program that supports the Unitarian Universalist Service Committee's human rights work around the world. Their projects have made a real difference in people's lives. Grounded in Unitarian Universalist values, UUSC is a nonsectarian 501 (c) (3) organization, open to all. Boxes distributed on Dec. 4 and returned on 18th. This is <u>not</u> a shared plate.

First UU Human Needs Fund

December 24, 2016

\$1,774.75

To help our members and attending friends during financial challenges, our church has a Human Needs Fund, the purpose of which is to provide monetary support in times of need. The fund can also be used to improve accessibility, remove barriers to full participation in the life of our church community, or for financial emergencies that arise. The camp focuses on building a positive community and provides a safe, stigma –free place for participants to express their true identities.

Immigrant Law Center of Minnesota

\$1,822,00

The ILCM is a nonprofit organization that provides legal services, education, and advocacy to low-income immigrants and refugees. Based in St. Paul, with outstate offices in Austin, Moorhead and Worthington it serves immigrants and refugees of all nationalities and all legal statuses.

Task Group Members

Vision of the Task Group

- The Task Group's goal is to enable our congregation to become engaged, educated and informed advocates for members and their families and for others living with disabilities.
- The Task Group focuses on projects that help our congregants to support and be more sensitive to issues of inclusiveness and hospitality toward our members and their families who are living with disabilities.
- The Task Group's efforts are built upon UU principles, to be carried out long term. It will take time to create a change in attitude, assimilate these changes and provide hands-on experiences that will enrich the lives of congregants and help them to understand and appreciate the needs of people living with disabilities.
- The task group is actively engaged in becoming a certified congregation through the Accessibility and Inclusion Ministries (AIM) program of EqUUal Access, part of the UUA.

Accomplishments of the Task Group

- It was announced at General Assembly, June 2013 that our Church would be one of 8 churches within the UUA to field test the Disability/Ability Action Program Handbook. Now referred to as AIM (Accessibility and Inclusion Ministries). We completed Phase 2 of this process, completing our action plan in May 2017.
- In conjunction with the communications committee our webpage has been updated.
- We presented a worship service March 26, 2017; If you've met one person with Autism, you've met one person
 with Autism. Two members of our Church Sam Olson and Gloria Marmolejo shared their personal stories. Jon
 Sailer from the Rochester Center for Autism was an outside speaker. The shared plate was the RT Autism
 Foundation/Project Lifesaver.
- We met twice with the City of Rochester Park Department looking at the accessibility of our parks and what role our group may play in advocating for this in the future.
- We did a "smart phone" blitz enlisting support of the congregation around the concerns of lack of increase in compensation for support staff working in group homes for people with disabilities.
- We provided a special page for the Ministerial Search Committee Packet about the work of the Disabilities task group.
- The group would like to thank the Property committee for new signs re limited mobility parking in the upper parking lot. The group would like to thank Rev. Fritz for giving up his upper parking lot spot on Sundays!!
- Our new water fountain, installed by the property committee meets all requirements for accessibility.

Task Group Goals for Next Year

- Continue our maintenance goals of reviewing disability resources, updating our website as needed and forwarding any legislative issues impacting the Disability Community to congregants.
- Complete Phase 3 of the credentialing process and apply for certification as an AIM congregation
- Look for opportunities to partner with other Social Justice initiatives at Church, advocating for people with disabilities.
- Participate in the kitchen remodeling project
- Present a worship service
- Continue to recruit new members. We welcome Schalleen Nelson and Peter Hoffman to the committee.

Disability Task Group: List of accomplishments for the Aim certification process: 2014-2017

Items proposed by our plan that were accomplished:

Workshops: We were required to complete 4 workshops. We planned to do 2 in RE.

- <u>Language Matters</u>: Completed January 31, 2015 as part of the all church midwinter retreat. Presented by the ARC of SE Minnesota
- <u>Introduction to Disability work in the Congregation</u>: Board Meeting April 2015. Summary of Survey and work we would do based on the results.
- Nick Meets the Man in the Wheelchair: Presentation by Richard Noll Feb 15, 2015 to RE classes. Rick has Spina Bifida and uses a wheel chair.
- <u>Super Hero Chalice Camp</u>: July 23, 2015. Shelly Maciujec, member of the Disability Task group who uses a wheel chair, spoke to 52 children at camp following a lesson based on the story of Christopher Reeves. She discussed what the church has been doing to welcome people with disabilities and make the church more friendly and accessible.

Worship: We were required to do one service as part of the certification process: We did two:

- <u>'Breakfast of Champions'</u>, January 31, 2016, part of the 150th Anniversary Celebration. We honored two
 members of our congregation; Kathe Yoss and Dorothy Hedgecock for their contributions to disability
 work.
- '<u>If you've Met one person with Autism, You've met one person with autism'</u>, March 26, 2017. Two members of our congregation told their stories and Jon Sailer from the Rochester Center for Autism was an outside speaker.

We had a shared plate at both services for Ironwood Springs Christian Camp: Wheelchair camp, and RT Autism Foundation/Project Lifesaver.

<u>Projects</u>: We were required to do 8, One social justice project, and projects regarding accessibility and inclusion.

- <u>Jumping In</u>: We created a survey called <u>What do you need to Fully Experience Congregational Life</u> that was distributed mainly after 3 services, and mailed, which was completed by 54 congregants. This survey was the basis of the presentation to the board.
- <u>Did you Know? (Information Blitz)</u>: Our webpage was updated under 'Social Justice' on the First Unitarian Universalist Church web page. Information about being accessible is also listed under 'About Our Church'. Periodic articles appeared in the 'Venture'. A feature article about the Task Group was in the 'UU Revue'. We submitted our own page as part of the Ministerial Search Packet, highlighting our work. An updated webpage is a required element of the credentialing process. We were told ours could be a model for other congregations to use.
- ReelAbilities: We had hoped to offer a fellowship type activity to visit the Reel Abilities Film Festival in St.
 Paul. This event was greatly curtailed in 2015, so we offered a showing of a film about Ironwood Springs
 Wheelchair camp that had been shown at the Reel Abilities film festival in 2015. Film was shown at our
 Church January 31, 2016. It was shown in the afternoon of the day of our service. Bob Bardwell, Director of
 Ironwood Springs, was present.
- <u>Under Cover</u>: The UU Book Club selected books in February 2015 and March 2016 around disability related themes. The books read were: <u>Good Kings/Bad Kings</u> in 2015 and <u>Wonder and Stop Pretending</u> in 2016.
- Beyond Our Walls: Steps to insure accessible space when we are not at church. Venues away from Church are more carefully looked at. This was a consideration in planning the 150th anniversary event. This was a consideration when the Silver and Gold dinners were planned, making sure one venue was accessible. There is greater awareness within the congregation about this.
- Engaging in Disability Rights: A Multi-generational Project: This was a required element of the credentialing process and gave us the greatest difficulty in doing. We spend many meetings and much time trying to work on this. We had two conversations with the Park Department about accessible playgrounds. We talked with Amy Nelson about the accessible playground project at Ben Franklin School. We are still in conversation with the Park Department. We had an information Blitz on two Sundays in March 2017 handing out information about the crisis for support staff in group homes working with people with disabilities. Raises for these workers have not been approved by the legislature and shortages of staff are at a critical level. An e-mail and text messaging blitz was done. We also co-hosted the fund-raising event

- held at our Church for Lee McKeeman February 2016. Lee's walk on the Appalachian Trail was to raise awareness of Mental Illness.
- Are We Accessible Yet? A new Semcil survey was completed in September 2, 2015 with members of the Property committee also present. We have been working to follow up on the recommendations. New tables were purchased in the commons area. Accessible towel racks are in both bathrooms. Automatic door openers are in both bathrooms. Additional limited mobility parking has been added to the upper parking area. A greater awareness of having accessible aisles in the Commons area, especially from the elevator into the Commons. Clearing the elevator areas of "storage". The new water fountain (funded by the Clara Barton Guild) was installed following Semcil guidelines.
- It's in Every one of us to be welcoming: We have met with the Hospitality and Fellowship committees. We wrote 'Reminders and Tips to Provide a Welcoming Community for People with Disabilities' to be used by ushers and greeters. One member of our church noticed how cumbersome it was to use our large print hymnals; they are in 3 volumes and heavy. Because of that suggestion, now if you take a large print order of service, the hymns for the service are printed and included.

Activities:

Service:

Several members of the Task Group and others in the congregation participate in a volunteer program at
Riverside Central School assisting kindergarten and first grade students with reading. After piloting the
program for seven months, beginning in September 2016, the task group invited others in the
congregation to participate. We now have volunteers working with students up to fourth grade. The
program was initiated by the local chapter of the NAACP.

Education:

• In March, 2017, Char Kunkel and Ron Ferguson of Luther College presented the results of the 2016 Olmsted County Racial Attitudes Survey to the Task Group. Once the study results have been published (in July 2017), the task group will share the results with the congregation.

Witness:

• The Task Group initiated a Congregational Resolution on Immigrant Rights and Sanctuary at its March 2017 meeting and began the discussion and discernment phases in April. As part of those phases, the Task Group conducted two forums by year end (April 23 and May 21), hosted a discussion table between services every Sunday since April 9, established a "question box" both physically and on the church website, and prepared a series of "matters of the congregation" presentations on issues related to undocumented immigrants presented in Sunday services beginning April 16.

Advocacy:

- The Chair of the Task Group worked with District staff from June to September 2016 to acquire student discipline data for the 2015-16 school year and analyze it by school, race, and free and reduced price lunch status. In cooperation with the Minnesota Education Equity Partnership, the NAACP, and Rochester for Justice and with the assistance of the Somali American Caucus, the Task Group conducted a forum on discipline disparities in Rochester Public Schools. In contrast to some assertions that disparities were the result of income and not race, the analysis showed significant racial disparities in discipline even after accounting for income.
- As an outcome of the February 4, 2017 forum, the Task Group and NAACP jointly submitted a request to the District in April 2017 that it regularly release discipline data disaggregated by school, race, free/reduced price lunch status, and special education status.
- Three members of the Task Group (including two members who are also members of the NAACP Executive Committee) met with School Board members in May 2017 to discuss the issues with analysis of district data
- The Task Group has made contact with the American Indian Parents Committee to work on issues affecting American Indian students.
- Members of the Task Group serve on the District's re-convened Community Focus Team working on discipline disparities and the achievement gap.

Community Organization:

- The Task Group participated in several fellowship activities building relationships with local minority communities and organizations.
- As part of the sanctuary resolution discernment process, the Task Group has developed relationships with local Hispanic/Latino groups, ISAIAH, and a few area faith communities.

- The Task Group works closely with NAACP, the Diversity Council, Rochester for Justice, and others on an ongoing basis.
- The Task Group co-hosted very well-attended candidate forums prior to the 2016 election.

Major Expenditures

\$250 donation to Minnesota Education Equity Partnership; miscellaneous expenditures related to refreshments and childcare at forums.

Task Group Goals for Next Year

- Combat racism and its variant forms.
- Hold local institutions accountable for eliminating institutional racism.
- Continue discernment activities leading to a vote on the Immigrant Rights and Sanctuary resolution.
- If the resolution is approved, begin implementation of sanctuary support activities; in either case, advocate for undocumented immigrants and other marginalized members of our community
- Increase congregational involvement in the NAACP volunteer reading program
- Continue to collaborate with area organizations to improve School District performance on achievement gaps, discipline disparities, and school integration
- Begin to address congregational education with regard to Olmsted County Racial Attitude Survey results and issues of white privilege
- Continue to support the Standing Rock Water Protectors' efforts to attain environmental justice

Social Justice Council: Refugee Resettlement Support Task Group Submitted by Elizabeth Katzmann, Chair

Forty-two church members and friends are signed up as volunteers. All interested in working directly with families have completed VIRTUS training and orientation to the Catholic Charities Refugee Resettlement Program (CCRRP). Lisa Teixeira, CCRRP coordinator, contacts volunteers directly as needs arise. Areas of assistance include: family mentors, donations/donated items, welcoming meal providers and grocery shoppers, and drivers. Other subgroup members volunteer at Hawthorne Learning Center as tutors and nursery caregivers.

A poster was prepared and presented at the Social Justice Council Information Fair last fall. Seven people inquired further about training and activities.

Julie Gilkinson and I led a Social Justice Sunday activity for the Religious Education classes on October 23, 2016, focusing on shelter and feeling safe, which included packing suitcases, backpacks, and duffels with pots, bottles of water, dishes, bowls, utensils, and foodstuffs, blankets and clothes, and walking half a mile around the church and through the neighborhood with them in tow. A lively discussion about the experience of fleeing ensued.

The Mike Podulke Memorial Auction in November designated the CCRRP as recipient of targeted donations, and \$4,700 was raised for household goods, hygiene needs, art and school supplies, refurbished computers and hookups, and bus passes. Thank you all again!

A collection of household and personal items was completed in December, and the stuffed boxes and bags completely filled our station wagon for delivery.

We can continue to welcome refugees by continuing work with CCRRP and Hawthorne Learning Center. We can educate ourselves and others about refugee resettlement issues and processes. We can initiate political actions by letter-writing, calling our elected officials, and demonstrating. We can donate locally and internationally to support groups in the field. We will remain open to call ourselves to action.

Regular Activities:

- 5. Discussed the merger of *Standing On Side of Love (SOSL) committee with us as SOSL is composed of Jeff and Julie Larson Keller. Agreed to merge these two groups as our activities have the same focus of welcoming all to our church and advocacy.
- 6. Planned a transgender service for January 29, 2017 led by Rev. Karen Hering, from Unity Church-Unitarian, St. Paul. Her son, Catherine (Cat) Charles Hammond, a Minneapolis-based writer, musician, and performer presented an afternoon workshop, Gender 101 that was attended by 30 or more people from the church and community.

Special Activities:

- 1. Organized a vigil following the Orlando massacre at the Pulse nightclub and held the service in the Memorial Garden on June 21, 2016. Attended by 25 people.
- 2. Met with Rev. Fritz Hudson to discuss ways to counteract the increased bigotry and hatred since the Presidential election. Partnering with community organizations to offer our space rent free or at a reduced rent was a possible idea. Reconnecting with other social justice workers in the community was another idea.

Social Justice: Community Service Outreach Groups

AARP Tax Program for Lower Income Families Submitted by Ella VanLaningham

The AARP Tax-Aide Program helps lower income individuals and families fill out their tax returns – enabling them to meet their tax obligations and obtain the maximum refund for which they are eligible. The program is operated by volunteers. Tax preparation and electronic filing is free. Help is provided at three major sites in Rochester, one in Stewartville and one in Dodge County, and volunteers travel to various senior facilities in Rochester and surrounding communities.

Overall this season to-date, assistance was provided to 3866 taxpayers, representing 3297 families, and volunteers donated over 10,000 hours (including training). Individuals and families can still get help during some limited summer sessions at the Rochester sites (Salvation Army, Senior Center and Hawthorne Education Center) by calling for an appointment in early summer; a special rent/property tax refund is available for lower income individuals/families for which a return can still be filed with the Minnesota Department of Revenue. Summer appointments can be made by calling 287-1958 which is a number set up by the United Way to help with scheduling.

We advertise the free tax program within the church community and hope to continue to expand congregational awareness. The group hopes that more taxpayers in the congregation might take advantage of the program and there might be more participation by members and friends as volunteer tax counselors, receptionists and phone schedulers.

Community Food Response (CFR) Submitted by Ella VanLaningham

Since September 2001, our congregation has been a cooperating church among 18+ groups that assist at least one day a month with sorting and distribution of excess food from hospitals, restaurants, businesses and grocery stores for the Community Food Response (CFR) program located in the lower level of Bethel Lutheran Church.

Our church continues to provide adequate volunteers for the 5th week collection, sorting and distribution of foods. In 2016, CFR collected 95.7 tons of food from 34 donor sites, and provided nearly 85,000 meals, including items for the next day's breakfast or lunch. An average of 75 families (225 individuals) was served every Monday, Wednesday and Friday.

Many thanks to the over 40 church families and friends who have helped with this project. Special thanks to Maggie and Roger Nolte who generally oversee the opening process, Anne Black-Sinak, Ronice Donovan, Kay Eberman and Ella VanLaningham who oversee the closing process, Linda and Bill Thompson who regularly do food pick-up, and Ash Gupta, Dave Kallmes and Cathy Stroebel who have served on the CFR Board over the last year. Family Promise of Rochester (IHN) Submitted by Phyllis Beery, Joyce Wood, Julie Gilkinson, Lynne Kirklin

Group Members

Phyllis Beery, Julie Gilkinson, Lynne Kirklin and Joyce Wood serve as coordinators for the UU Interfaith Hospitality network portion of Family Promise. There are about 49 congregants that volunteer. Family Promise Rochester offers food and shelter 365 days a year to homeless families through Interfaith Hospitality, which is composed of close to 40 faith communities.

Meeting Information

One of the coordinators attends the SJ Council meetings and gives an update

Coordinators attend quarterly meetings each year led by Family Promise director, Karen LaFee, which address program issues.

UU, UCC, St. Pius and Good Shepherd met several times to discuss concerns in losing UCC as our host church and Good Shepherd becoming our host church.

All new IHN volunteers are required to attend an informational and sensitivity training. Continuing volunteers attend re-training every three years. Training is offered at various sites throughout the year and on-line training is now available. All volunteers must complete a criminal back ground-check as well as read the IHN Behavior Policy and sign off on that policy.

Regular Activities

This past year, our host church, UCC, found itself without a coordinator. After hosting June 11- 19 and August 7 – 14, 2016 with UCC, we started looking for a new host church.

In the meantime, UU volunteers filled needed spots for other churches who needed extra volunteer help. Early in 2017 Good Shepherd Lutheran Church offered its facility, but could not offer any volunteers at this time. We just finished our first week at Good Shepherd (April 30-May 7) with us coordinating assisted by buddy churches, UCC and St. Pius, volunteers.

The primary focus is ongoing recruitment of volunteers to staff buddy weeks and education of our church community about homelessness in the Greater Rochester Area. Recruitment occurs through the Venture, website, E News, member interest forms, Social Justice Fair and person to person contact.

Special Activities

Cardboard Box City was not held this year. We did not participate in the IHN choir concert though did contribute a basket for the silent auction fundraiser associated with the concert.

We publicized two fundraisers - "No Place Like Home" gala a Somerby last June, and "Open Your Heart" a Valentine's week on-line donation challenge.

Expenses

Generally, there are no expenses but this spring the SJC reimbursed the money spent for the food and beverages purchased for breakfasts and lunches for our hosting week: \$34.20.

Family Promise asks that a church our size contribute \$1,000 annually. We were able to do this through the shared plate collection in November that brought in \$1,057.

Goals for Next Year

- Continue to recruit new members
- Encourage UU support of Family Promise Community events, such as the choir concert, "No Place like Home"
 Gala (June 15, 2017), and 5K race, if it is held again.
- Develop a partnership with Good Shepherd Lutheran Church to get back to volunteering four weeks during the year.

SOCIAL JUSTICE: COMMUNITY SERVICE OUTREACH GROUPS (CONT.)

<u>Saturday Noon Meals (SNM)</u> Submitted by Roxanne Schlasner

We had four Saturdays volunteering at SNM this year. June 25, August 27 and October 15 in 2016. Saturday Noon Meals is the Channel One Agency that feeds those in need. The mission is: To serve an attractively nutritious meal in warm safe atmosphere for persons in need. It is served at Christ United Methodist Church, 400 5th Ave. SW. This program encourages us to practice the first and second principle. *First Principle* encourages us to "Inherent Worth and Dignity of every Person". At Saturday Noon Meals, the meal is served family style to those sitting a community table of eight. The program encourages us to call the homeless and hungry who patriciate a guest. Just as you would have a guest over to meal you decorate the table with flowers and serve appetizers. *Second Principle* is encouraging us to practice "Justice, Equity and Compassion in Human Relations". Preparing a home-style cooked meal for the hungry and homeless is action of compassion.

Saturday June 25, 2016 - meal

Seven members volunteered at Sat. Noon Meals on June 25th. Marie and Carmina Davidiak, David Maciujec, and Roxanne Schlasner prepared the meal and appetizers. The meal that was prepared included lettuce salad with ranch dressing, lasagna, corn, butter/ garlic Italian bread with milk and ice c ream drumsticks for dessert. For appetizers, open face (tea time size) ham sandwiches, chicken wings and fresh veggies were prepared. At 11:00 Julie Gilkison, and Paulette DeMers, Mike Tinetti and Roxanne Schlasner helped serve the meal and clean up; the Latter-Day Saints volunteers helped with serving as well. Roxanne read the blessing of from the book "Bless This Food". We served 65 guests in the dining room, with the meals counted that volunteers ate and all the take home meals the meal made for 100 guest was gone. Holiday bags were given out as guest left the dining room – the holiday celebrated is "RochesterFest".

Saturday August 27, 2016 - meal

Eight of us volunteered at Sat. Noon Meals. Linda Curtis, coordinator of SNM stated that the guest numbers are very low compared to last year 40 to 50 per Saturday vs the 70 to 80 that used to come. All of the noon meal programs are experiencing this decrease in numbers for the meals. Jeanne Hoecker and Roxanne Schlasner arrived for cooking. The menu was spaghetti, corn, fresh tomatoes, fresh refrigerator pickles, lettuce salad with ranch dressing, garlic bread, strawberry fluff pie. At 11:00 two members of the Sikh Society of Rochester (SSRM) joined the group. They found our volunteer opportunity thru the website; Ravindr Sing and Deb help us out. Other UU members that joined Jeanne and Roxanne were: Becca Blouin (teen), Julie Gilkinson, Mike Tinetti, Joyce Wood. All volunteers have had the orientation information so it was not given. Roxanne read the blessing before the meal using a blessing from the book "Bless This Food". We served 54 guests in the dining room, two families and one service dog included and four take home meals that were picked up. Many of the guests took home the extra food.

Christmas treat bags were decorated. Family's donated Kleenex and hand sanitizer to place in the treat bags.

Eighty-five percent are at or below poverty level. Most are immigrants. HH store stocks free items unavailable from SNAP. In 2nd year of operation, over 8,440 items were distributed to 4,220 shoppers.

- Communicated with Hawthorne Education Center Management, Staff and Health Services.

Activities of Committee

- Maintained core of UU volunteers and coordinated required District 535 training.

- Reviewed our monthly financial reports to monitor income and expenses, making recommendations as needed.
- Moved the ACH (automatic deposit/debit account) from Bremer Bank to F & M Bank due to higher fees imposed by Bremer.
- Reviewed and updated the Reserve and Special Funds Authorization policy; the Finance committee description; the Memorial and Commemorative Fund policy; the Human Needs Fund policy; the Sharing the Plate with a Charitable Organization policy.
- approved or recommended to PAC Team/Board the following funding requests:
- up to \$750 requested by the RE Council, from the Memorial and Commemorative Fund for the Maypole RE wing mural, designed and completed by Greg Wimmer this winter (completed)
- up to \$500 requested by the DRE, for a new rocking chair in the nursery from the Memorial and Commemorative Fund (purchase completed)
- up to \$2500 requested by Design, for an additional name tag case and replacement of plastic strips holding tags on current cases (work in progress)
- up to \$400 requested by Co-Administrator- Office for purchase a refurbished laptop computer from Bight Eyed Computers when one failed suddenly. (purchase and installation complete)
 - approved another \$2796 in roof repairs in April.
- approved almost \$89,000 in funding from Major Maintenance/Replacement/Jumpstarter Fund for audio/video upgrade, handrail upgrade, roof repairs and life extension work, improved lighting in the chapel.
- reviewed plans for Stewardship campaign and assisted as needed when asked by Stewardship Chairs, **Jim Jensen** and **Chris Wendt**. (See the Stewardship report for the summary of this year's campaign.) Thanks to Jim and Chris for their work on this year's campaign, to the **Board members** for their assistance and to **Jerry Katzmann** & **Gail Bishop** for their leadership and efforts on this year's campaign.
- **Proposed Budget for June 2017- May 2018**: Worked with the treasurer & recommendations from Program Council to formulate a proposed operating budget for the next fiscal year (June 2017- May 2018). This is first drafted in January-early February, based on requests from staff, PAC/ Board, committees & Program Council, so Stewardship can build the budget goals into their campaign for the following year.

Once the Stewardship campaign is completed and we have an idea of pledges made & income expected, we acquire input from Program Council & work with the treasurer to make necessary revisions in the draft budget and then make a recommendation to the PAC Team & Board on the final operating budget for 2017-2018.

Special Activities of Finance:

- Organized and conducted our annual **UU Auction held on Nov. 12, 2016.** The auction is one of our main sources of income in addition to income from our pledges, plate, rentals and miscellaneous interest. We were able to donate \$4700 to the Catholic Charities Refugee program, even though the auction was about \$7000 short of it's goal to raise \$28,000 for our budget this year. Energy and participation at the 2016 auction was down from other years and

bidding was also more reserved. Perhaps that was due to the auction following this November's election, but in any case, the energy and the mood of the evening were markedly different from previous auctions.

Thanks to everyone who did attend the evening and to our devoted committee members who each contributed to this event: Dave & Pat Siljenberg & Melissa Eggler for their organizing of the silent auction; Nathan and Ramona Harff for their set up of the fixed price items; Sue Wheeler for her data entry of auction items as they are donated; Rob Harveland for finalizing the auction bill and generating all the reports for donors and bidders; Randy Crawford for his assistance the night of the auction entering bids/bidder; Ash Gupta for helping to greet attendees; John Kruesel and Stephanie Podulke for their emceeing of the live auction and the Social Justice Council for identifying the charity organization that is supported via items at the live auction. Also, thank you to Gail Bishop, Linda Thompson and our sextons for organizing and providing the food and beverages available during the silent auction and to the many volunteers who helped set up the refreshments and cleaned up the leftovers and kitchen

The **2017** Auction will be held on Nov. **11**, **2017**. John Kruesel has confirmed his availability for that evening. If you have suggestions for the auction or are interested in helping organize the auction, contact one of us on the committee.

The first official meeting this year of the Committee was held on April 9, 2017.

Special Activities of the Committee:

Our first library event was held on March 12 between services highlighting the Jewish Holiday of Purim. Books and handouts were available for both children and adults. Kay Udey provided the traditional hamantaschen for all to enjoy.

A second event was held on May 21 focusing on Ramadan. Rana Mikati from the Rochester Muslim Community Circle shared her knowledge and faith. Books, handouts, and special treats were provided. Special Activities of the Library:

Every registered user with a computer, tablet, or smartphone will now have access to the database with the ability to search for and check out library materials. Kate spent many hours scanning all of the adult and children's books into our Libib.com site and entering books without barcodes by hand. Regular Activities of the Committee:

- Monthly outdoor property work days typically from April through November of each year, to maintain church grounds and the building exterior, under the direction of Bill Thompson.
- Occasional indoor property work days.
- Maintain building, ensuring it is clean, safe, and the physical infrastructure is in good operating condition.
- Field requests regarding interior and exterior property matters- from the church office, other committees and church members and timely resolution of those requests.
- Anticipate and communicate upcoming repairs, maintenance, or upgrades needed for the building and grounds.
- Communicate with church office about which items our building custodian can support.
- Work with the Design Committee on any major projects or expenses.
- Building Sextons provide input to the Property Committee based on their observations.
- Prepare budget for Finance Committee.
- Take recycling to Rochester waste facility.
- Sign contracts for lawn care, snow removal, elevator maintenance service agreements, and garbage removal
- Attend Program Council meeting and represent Property Committee issues and status.

Projects Completed by the committee since the 2015 / 2016 Annual Report include:

JumpStarter projects completed:

- Roof repairs in Summer 2016 and Spring 2017
- Exterior handrail removed / rebuilt / reinstalled in August 2016
- A/V- Sanctuary projector / camera / screen / audio board / sound system, Hearth Room, Nursery, Commons sound install / video pre-wire in Fall 2016
- Chapel room LED lighting upgrade completed in Jan 2017
- Church management software evaluation / selection Spring 2017 / implementation begun May 2017

Outdoor projects completed:

- Structure built over RE stairwell exit to minimize rain, melting snow, and leaf debris intrusion which caused flooding in RE hallway. Special thanks to Eric Eggler for his assistance.
- Love banner frame built and installed March 2017 in front of church.
- Century Link active cable laying on ground in back of church finally moved to power line poles by Century Link.
- 15 dead trees (some with emerald ash borer infestation) removed during past year. Special thanks to Eric Eggler, Don Hansen, Randy Crawford, Phil Wheeler, and Bill Thompson.
- Thanks to John Trnka for repainting courtyard table and chairs.

- Many species of native wildflowers were donated to the church by Joel Dunnette. These were either planted in the west butterfly garden or on top of the west slope, and several bulbs of nodding wild onions were planted in the top of the butterfly garden.
- And special thanks to the many volunteers who help on outdoor property workdays to help maintain our gardens and landscape.
- Invasive plant control:

"I have no wrath. Should someone give me briars and thorns in battle, then I would step on them, I would burn them completely." - Isaiah 27:4

- Invasive plant management was completed for garlic mustard, poison ivy, wild parsnip and buckthorn. Garlic mustard areas were sprayed with 2% glyphosate this spring, the remaining plants were pulled by hand, bagged and thrown in the trash. Poison ivy was sprayed last fall. Wild parsnip was dug up or pulled. The female Buckthorn trees (fruit bearing) were treated using a variety of methods - cut down, then stump was treated with 12.5% triclopyr or a few had basal bark treatment last fall. This spring more female buckthorn were cut down and stumps were covered with a tin can.

BUTTERFLY FLIGHT CREW 2016-2017 REPORT:

A. THE BUTTERFLY GARDEN is doing well with many plants established. Some maintenance work is planned for summer.

B. AMUR SILVERGRASS TARP TREATMENT OUTCOME:

As of April 2017, the tarps have been removed and there are several Amur silvergrass survivors near the shaded edges of the tarp that was removed in April. (The other tarp was removed in 2016 due to its opacity so it did not have the same success.) According to Dawn Littleton and Bill Thompson the edge-based silvergrass survivors will be sprayed frequently with glyphosate and the currently bare ground will be planted with native plants before invasives move in. While this may be a strong success for removing an invasive, we cannot say for sure until the end of summer.

RECOMMENDATIONS: For the Church's cultivated and non-cultivated areas (gardens, woodlands and prairie areas) to require less attention and maintenance, we recommend the following priorities:

Priority One: Eliminate the nine invasives known to be on any part of UU property before controlling non-invasive weeds (e.g., dandelions):

- 1. Garlic Mustard
- 2. Crown Vetch
- 3. Wild Carrot/Queen Anne's Lace L. (which invades disturbed areas only so we if have a happy ecosystem, wild carrot will cease to be a problem)
- 4. 4. Common Buckthorn (originally sold as a nursery plant)
- 5. S. Asian Bush Honeysuckle (still sold in nurseries and on the web)
- 6. G. Japanese Barberry (still sold in nurseries and on the web This is the new buckthorn as a forest/prairie invader).
- 7. Reed Canary Grass (still sold in nurseries and on the web)
- 8. 8. Creeping Bellflower
- 9. Cushion Spurge (still sold in nurseries, known to be toxic and this is now self-seeding into the UU natural areas)

Priority Two: The Butterfly Flight Crew advises on increasing the use of native plants including native aggressive plants. Native aggressive plants quickly establish on disturbed sites and over a few years "back off" as other gentler natives get established in less-disturbed soils, thereby increasing healthy habitat. (Typical examples of aggressive natives are common milkweed and goldenrod as they quickly stabilize the soil then they back off allowing other plants in). As we have observed at Churchinvasives work by quickly taking over healthy or disturbed soil, never backing off, and destroying wildlife habitat on their way (the nine plants above are excellent examples of not backing off).

Priority Three: Continue to allow black-out tarps of any size to smother invasives where they form monocultures. While the tarps are unsightly they require no herbicide, little volunteer effort, and are

extremely effective at killing very resilient plants. They do need to prevent light from hitting the ground, and they do need to be used for at least one or two growing seasons.

Priority Four: Form a committee to start screening all donations of plants and seeds for invasive species whether they are provided for the cultivated or non-cultivated sites. Virtually all of Minnesota's invasive plant species come from un-informed horticultural sales and gifts from others (apparently including those at our Church), causing an infinity of inefficient work to maintain healthy habitats for pollinators, birds, amphibians etc. on Church grounds.

- Replacement water fountain / bottle filler installed in main lobby; project was generously funded by Clara Barton Guild.
- Final 2 items on Cincinnati Insurance audit results completed installation of emergency light in CR / library hallway, and Hearth Room damper inspection (required reseating).
- Removal / recycling of Commons Furniture per Design Committee request.
- Commons closets cleanup / disposition of obsolete items, obsolete paint, and paint cabinet to free up space. Special thanks to Barb Foss.
- Upper parking lot signage purchased for some of the stalls stating 'Limited Mobility Sunday morning only'.
- Faulty relay which prevented hot water flow for RE heating was replaced.
- Participating in Historic Landmark designation with City of Rochester.
- 150th year banner removed.
- LED lighting in A/V cabinet in process, should be installed prior to 05/30/17.

Ella, Marge Dalen and Sandy MacLaughlin agreed to meet and bring suggestions for this year's donations to the October meeting. Sandy MacLaughlin gave us an update for Hawthorne Helps. The store is doing well with many volunteers and donations.

In *October*, Beth Atkinson shared thoughts and pictures from her trip to Bosnia and Herzegovina in summer 2016. She called it "Building Peace, One Note at a time". Ella VanLaningham presented what she, Marge and Sandy proposed for the 2016-2017 donations. They proposed giving Gage East, Hawthorne Helps, Planned Parenthood, and project Legacy each \$500. They also proposed the \$2,170 needed to replace the lobby drinking fountain. All proposals were moved and seconded to go ahead. The Christmas luncheon will be December 13th at Charter House and Kathe Yoss has agreed to take charge of it again. The cost will be a suggested price of \$12 with church staff members as guests. Sue Wheeler and Melissa Eggert have agreed to plan the spring rummage sale with the help of Margaret Brandl, Barb Foss and Sandy MacLaughlin. Clara Barton Guild members will sign up to help during set up, sale and cleanup.

In February, Harriet Hodgson gave the program about her new book" The Family Caregiver's Cookbook: Easy-Fix recipes for the busy Family Caregivers" She talked about how her new book grew out of the need for self-care. She also talked about what is involved behind the scenes in writing a cookbook. Sandy MacLaughlin gave an update on Hawthorne Helps. The spring luncheon will be held at Charter House in May. Ann Lien and Linda Thompson are in the process of buying a new hot water urn to replace the broken one in the church kitchen. We started discussing the future of the Clara Barton Guild. We talked about the need for monthly meetings since our present co-chairs will be done and no replacements have been found.

In *March*, Anne Black-Sinak showed pictures and talked about how she uses images from her camera to create her art. Sue Wheeler gave some information about the all church rummage sale coming up on April 22. This year people can sign up to help on SignUpGenius. This year, the church youth will have a bake sale during the rummage sale. People are encouraged to donate items to the rummage sale and treats for the bake sale. The new water pot cost \$63 and the new drinking fountain cost \$1635. Kathe Yoss gave several options for food available for the May luncheon. The group chose Polynesian chicken salad. The suggested cost will be \$12. Sandy MacLaughlin reminded us of the needs for Hawthorne Helps this month. She told us of the closure of days and hours at Hawthorne. Duane

Sauke has introduced a bill in support of the Hawthorne Bridges to Healthcare program which would enable Hawthorne to continue programming for current students transitioning to RTCT to Mayo School of Health Sciences and then to work. Sandy developed a questionnaire to gather input concerning the future of the guild and how and in what capacity it will continue.

Guild money is separate from the church budget so the committee makes its own financial decisions. Ella VanLaningham prepared a Treasurer's report (attached).


Goals
