- 1. **Call to order.** The meeting was called to order by Kim Reid.
- 2. **Chalice Lighting & Reflection.** Kim Reid shared her reflections of the Pilgrimage to Boston and the surrounding areas.

Some months, while programmatic planning is already underway for a lively fall, I prefer to take a wider view about the *why* of our work. And this piece of writing caught my attention recently, so I want to share them with you to reflect together in our shared leadership.

These words are from an online blog, *Peace Bang*, from the Rev. Dr. Victoria Weinstein, a UU Minister in New England, known for attending to cultural and spiritual trends with honesty and insight. Here is what she wrote just this summer, that I am wrestling with – and I wonder if you might be, too.

"The mainline Protestant church (and in this I include UUs, who are theologically diverse

but culturally extremely similar to mainline Protestants)

has often failed in its commission to be counter-cultural.

The church is now a regarded by most people as a product that exists to meet their needs,

or perhaps a fondly regarded public utility.

Church leaders and clergy are desperate to reconvene covid-diminished congregations

and/or to find new paths toward relevance and vitality.
What no one wants to openly admit is that
churches are spiritual communities, not service providers.
Nor, unless this is an explicit aspect of their mission,
are churches community program centers." (Peacebang, July, 2022)

I lift this up, as part of a larger writing that was about clergy burnout, though, to be clear, I feel strongly supported by this church and your leadership to care for soulful well-being and my family life — thank you - I lift this up at the same time I'm thinking about fall planning, wanting to be fully multi-platform similar to other public institutions, yet knowing we do not have a tech department and sufficient support staff to offer what is programmatically normative. I balance my own desire to create a modern church attending to the forms and modes that are culturally normative, alongside a deep resentment for over-productive and consumeristic cultures of capitalism and white supremacy that encourages us to create and provide more than we're able to sustain.

And here I am, stuck in the middle, as the song goes, with you – grateful for the challenge to hold these tensions together within the framing of our mission – welcome, compassion, spirituality, justice. There is much we can, and should do through those values, and we will. And I believe we can do it in such a way that leans more toward generative and inspiring work, and purposely leans away from over-exhaustion, over-work, and the idols of productivity. May our shared work be generative, life-giving, and sustained by offering each other grace and encouragement.
